

XTREME BAR BINGO OFFICIAL RULES (PLEASE REVIEW) (UPDATED 3/12)

1.

SPONSOR:

The administrators of this Sweepstakes are Ed. Tribout Inc. DBA Xtreme Bar Bingo with a principal place of business of 517 S. Il. St. Belleville Il. 62220 (the "Sponsor") and _____ with a principal place of business of _____ (the "Participating Location"). By participating in the Sweepstakes, each Entrant (defined herein) unconditionally accepts and agrees to comply with and abide by these Official Rules and the decisions of Sponsor, which shall be final and binding in all respects. Sponsor is responsible for the collection, submission or processing of Entries (defined herein) and the overall administration of the Sweepstakes. Entrants should look solely to Sponsor with any questions, comments or problems related to the Sweepstakes. Sponsor may be reached by email at Todd@xtremebarbingo.com during the Promotion Period (defined herein).

2. **ELIGIBILITY:**

Open to all legal residents of the United States of America who are twenty-one (21) years or older (the "Entrant"). Sponsor, and their respective parents, sales representatives, and each of their respective officers, directors and employees (collectively, the "Promotion Entities"), are ineligible to enter the Sweepstakes or win a prize. Household Members and Immediate Family Members of such individuals are also not eligible to enter or win. "Household Members" shall mean those people who share the same residence at least three months a year. "Immediate Family Members" shall mean parents, step-parents, legal guardians, children, step-children, siblings, step-siblings, or spouses. 3. GAMES AND DELUXE PRIZES:

There will be nine (9) total games that take place during each session. An Entrant wins a game by completing five numbers in a row or by getting the designated pattern, announced and displayed on the television in the location before the game. The numbers drawn are by using an RNG (random number generator) and are displayed on each television for all Entrants to see. For each game, the Entrant will be given a card containing five (5) horizontal rows of spaces, with each row except the central one containing five (5) figures. The central row has four (4) figures with the word "free" marked in the center space. An Entrant wins a game by completing a preannounced combination of spaces or, in the absence of a preannouncement of a combination of spaces, any combination of five (5) spaces in a row, vertically, horizontally, or diagonally.

Xtreme Bar Bingo Prize and Consolation Prizes: If a Deluxe Prize (defined herein) is not awarded during a Deluxe Prize Game (defined herein), an Entrant may win a consolation prize defined as an "Xtreme Bar Bingo Prize". The winner of Game 5 of the Deluxe Prize Games will receive a "Party Suite" to a Gateway Grizzlies game. The party suite includes 20 tickets to the game, wait service, complementary snack, one case of beverages (12 pack of Pepsi products & 12 pack of Budweiser Products). With the approximate retail value of \$500. Time and date of the game is at the discretion of the Gateway Grizzlies. IF THERE IS NO WINNER OF THE JUNIOR JACKPOT GAME, the cash prize is carried over to the next day (Monday Through Sunday). EACH WEEK THE JUNIOR JACKPOT INCREASES \$100 EVERY WEEK UNTIL THE JUNIOR JACKPOT IS WON. The Junior Jackpot increases on Wednesday (2/27). If an Entrant wins on any number of calls more than the number of calls announced by the caller before the Junior Jackpot Game, the Entrant will receive a consolation prize awarded by the Participating Location. This prize is awarded if there is no winner of the Junior Jackpot.

In the event of the Junior Jackpot being won at by multiple winners at the same location or at multiple locations, the winner(s) will be splitting the Junior Jackpot (stated prior to the game) in proportionate value to the number of winners.

receive an Xtreme Bar Bingo Prize, which holds the retail value of \$1.00 up to \$100.00. This prize is awarded if there is no winner of the Game 7 Deluxe Prize.

– Game 8- Deluxe Prize Games- An Entrant wins Game 8 of the Deluxe Prize Games by getting the combination of five (5) spaces in a row (including a free space), in ten (10) calls or less. The winner of Game 2 of the Deluxe Prize Games will receive a Amazon Fire Stick from the Sponsor. The Amazon Fire Stick is referred to herein as the “Game 8 Deluxe Prize.” If an Entrant gets five (5) consecutive spaces in eleven (11) calls or more, they will receive a consolation prize awarded by the Participating Location. This prize is awarded if there is no winner of the Game 8 Deluxe Prize.

EACH WEEK THE XTREME JACKPOT INCREASES ONE CALL AND \$1,000 EVERY WEEK UNTIL THE XTREME JACKPOT IS WON. The Xtreme Jackpot increases on Saturday (2/9). If an Entrant wins on any number of calls more than the number of calls announced by the caller before the Xtreme Jackpot Game, the Entrant will receive a consolation prize awarded by the Participating Location. This prize is awarded if there is no winner of the Xtreme Jackpot.
