# Xtreme Bar Bingo Official Rules & Terms of Participation

This document outlines the official rules, terms of participation, and legal considerations for Xtreme Bar Bingo, operated under Tribout Distributors. These rules apply to all participants and affiliated venues across the states in which the service operates. By participating in Xtreme Bar Bingo, players and hosts agree to adhere to the following terms and conditions.

## 1. Company Information

Xtreme Bar Bingo is a promotional entertainment program operated as its own entity under the ownership and management of Tribout Distributors.

## 2. Eligibility and Participation

Participation in Xtreme Bar Bingo is free of charge. No purchase, payment, or cover fee may be required by any participating venue to play.

Participants must be 21 years of age or older and must be physically present at the participating venue during the scheduled bingo session.

Employees and staff of participating venues are permitted to play.

#### 3. Structure and Game Operation

All prizes are distributed during the week following the applicable game. Physical prizes are shipped directly to the hosting venue for presentation to the winner, while digital prizes, such as gift cards and event tickets, are delivered electronically. Jackpot prize winners will be contacted directly by Xtreme Bar Bingo to complete all required tax documentation prior to disbursement.

#### 4. Prize Verification and Distribution

Each game offers a designated deluxe prize awarded to any player who achieves the required bingo pattern within a predetermined number of balls. If no player meets this condition, a consolation prize is awarded instead. In the event of a tie for a deluxe prize, all qualifying winners shall receive the full prize. Consolation prize ties are resolved at the discretion of the hosting venue. Jackpot prizes are divided equally among all verified winners.

Prize eligibility and claims are contingent upon successful verification of the bingo card through a unique alphanumeric code embedded on each card. No prize shall be issued without proper verification.

Prizes are distributed the week following the win. Physical items are shipped to the bar; gift cards and tickets are delivered digitally. Jackpot winners are contacted directly to complete necessary tax forms.

## 5. Jackpot Games and Limits

Xtreme Bar Bingo includes two state-specific jackpot games: the JR Jackpot and the Xtreme Jackpot. Jackpots increase weekly until claimed. Current jackpots may exceed \$15,000. All jackpots are paid by check and subject to tax withholding.

#### 6. Personal Information Collection and Use

We collect name, email, and phone number solely for prize fulfillment and internal verification. This data is stored securely and is never sold or shared with third parties.

Participants may request deletion of their data at any time by contacting us via email, phone, or social media.

If required, Xtreme Bar Bingo is willing to adopt retention limits in compliance with applicable laws.

# 7. Consent to Photography and Media

By participating in Xtreme Bar Bingo, players consent to the use of their photo, video, or likeness for promotional and marketing purposes without additional authorization or compensation.

# 8. Technical Support and Fair Play

All gameplay is final. Replays or game restarts are not permitted under any circumstances. Real-time technical support is available during each event via the contact number provided on-site. Xtreme Bar Bingo will make all reasonable efforts to address and resolve any technical issues in a prompt and equitable manner; however, all final decisions rest with Xtreme Bar Bingo.

### 9. Game Cancellation and Location Termination

Participating bars may cancel scheduled Xtreme Bar Bingo events at their sole discretion. Xtreme Bar Bingo will continue providing service to each location as long as participation is active. There are no cancellation fees, and all event scheduling decisions are made by the individual venue

# 10. Compliance and Licensing

Xtreme Bar Bingo operates as a free-to-play entertainment promotion and is currently active in Illinois, Missouri, Wisconsin, Colorado, Arizona, Tennessee, Indiana, and Kentucky.

All prizes are predetermined and disclosed to participants before play begins. Prize values, patterns, and criteria are displayed prior to each game.

# 11. Agreement and Amendments

Participation in Xtreme Bar Bingo constitutes acceptance of these terms. Xtreme Bar Bingo reserves the right to update this policy at any time. All legal reviews and required modifications shall be made by counsel as appropriate.
